Rental Service Covered Under this Agreement

The contracted price includes all services listed below. It DOES NOT include crash damage (for any reason, and regardless of cause or fault) or abuse, including but not limited to tires, wheels, engine, transmission, or any other component of the car. Specific to EVSR rentals: any physical damage to the motors, controllers, battery pack and wiring is NOT covered in the contracted price.

- **Preparation and Delivery:** Racecar will be delivered to the contracted event in race ready condition.
- **At Event Service:** Standard track services include all fluids monitored, suspension, tires, and general upkeep during the day. Assisting the driver in and out of the car and general courtesy extended to all team cars and participants.
- **Race Gas, Fluids, and Car Supplies:** All fuel, fluids and supplies required to run the day. Battery charging will also be provided if the rental is an EVSR.
- **Registrations, Entry Fees, and Memberships:** Entropy Racing is NOT responsible for entry fees, memberships or registration costs. Entropy Racing will assist you in submitting the appropriate paperwork.

Extra Cost Services

- **Damage Repairs:** any and all damage sustained on the rented vehicle REGARDLESS OF FAULT or CIRCUMSTANCE is chargeable to the renter and payable immediately. All pricing of parts and labor are at the sole discretion of Entropy Racing.
- **Complete Write-Off of a Rented Vehicle:** At the sole discretion of Entropy Racing, an extensively damaged racecar may be declared "totaled". This means it has been deemed non-repairable and the total value of the car will be assessed as the damage to be paid. Entropy Racing will endeavor to, but is not obliged, to reduce this cost by recovering parts from the damaged vehicle and credited the renter's damage bill. The total value of an Entropy Sports Racer (ESR) is \$12,000.00. The total value of an Electric Vehicle Sports Racer (EVSR) is \$75,000.00.

Cancellation Policy

Booked events that are canceled by the renter are subject to a cancellation fee of 50% of the total fees due if notice is given three or more weeks prior to the first day of the event. If notice of a cancellation is received between 10 and 20 days prior to the first day of the event, 75% of the total fees are due. If the renter cancels the event less than 10 days prior to the first day of the event, the entire fee (100%) is due.

In the event that an event is canceled by the sanctioning body, track, or is due to weather or other circumstances beyond anyone's control, Entropy Racing will refund all monies if this were to occur 48 hours or more, prior to the first day of the event.

Should an events be canceled with less than 48 hours prior to the first day of the event, Entropy Racing will retain 25% of the fees due to offset preparation and/or travel expenses.

Disclaimers

While every reasonable effort will be made to prepare a successful and safe racecar, there can be no guarantee that any racecar will finish a race or a session. The failure of the racecar to perform properly, in no way entitles the customer to a refund once he or she has put a wheel on the racing surface. Entropy Racing is entitled to its full fee, regardless of circumstance.

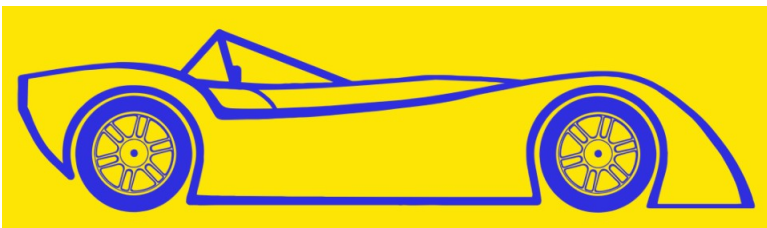

Entropy Racing's liability resulting from its failure to provide racecars for the scheduled event is limited to a full refund for any monies paid for that event.

THIS AGREEMENT RELEASES ENTROPY RACING FROM ALL LIABILITY**

**YOU ARE GIVING UP IMPORTANT LEGAL RIGHTS – READ THIS AGREEMENT CAREFULLY BEFORE
SIGNING**

RISK OF INJURY OR DEATH TO ME: I, _____, am aware that my presence at the race track or event in any capacity, whether involved in pit crew activities, spectating, flagging, driving an automobile, or riding in an automobile on a race track or temporary circuit designed for, and used as, a road course, whether in a race, time trial, driver education program, or practice, testing, or otherwise is hazardous. I wish to participate and/or receive instruction in these activities with Entropy Racing with the full acknowledgment of the dangers involved, and hereby agree to accept any and all risks of injury or death that may occur.

RISK OF INJURY OR DAMAGE TO MY CAR OR TO OTHER PERSONS, OBJECTS OR ENTITIES: I understand that driving my own car on a race track or temporary circuit designed for, and used as, a road course, whether in a race, time trial, driver education program, or practice, testing or otherwise creates substantial additional dangers, especially to the driver. I understand that when my car is being driven by a member of Entropy Racing, that driving is on my behalf and I accept responsibility for all damage and injury and consequential damages that might arise from the actions of a member of Entropy Racing vis-à-vis driving my car.

GIVING UP MY LEGAL RIGHTS: By signing this Agreement, I agree to give up certain legal rights which I may have in the event I become injured or killed participating or receiving instruction in motorsports with Entropy Racing. I am giving up my legal rights against Entropy Racing as well as against Charles Lee Greenahus, Entropy LLC, its agents, officers, directors, employees, and contractors. As used in this Agreement, the words “Entropy Racing” will mean Charles Lee Greenahus, Entropy LLC, its agents, officers, directors, employees, and contractors.

MY PROMISE NOT TO SUE: I agree that I will not sue, or otherwise make any claim against Entropy Racing for injury, death, or damage to me in the course of my participation or instruction in motorsports, in any way resulting from the negligence or other acts, however caused, of Entropy Racing.

MY RELEASE OF LIABILITY: I also agree to release and discharge Entropy Racing from all actions, claims, or demands, both for myself and/or my heirs or personal representatives, for injury, death, or damage to me in the course of my participation or instruction in motorsports, in any way resulting from the negligence or other acts, however caused, of Entropy Racing.

MY PROMISE TO INDEMNIFY: I agree to pay all cost and expenses, including attorneys’ fees and court costs, that Entropy Racing may incur as a consequence of any legal action arising out of injury, death, or damage to me OR injury, death, or damage to someone else as a result of my conduct.

MY CONSENT TO MEDICAL TREATMENT: I consent to any hospital care or medical or surgical diagnosis or treatment rendered to me, or to persons, or to members of my family who accompany me, as found advisable, of any injuries that may arise from participation in activities with Entropy Racing. I also understand and agree that I am solely responsible for any applicable charges for such medical services.

All terms of this Agreement are binding upon me, my relatives, heirs, and personal representative. The terms of this Agreement shall also be binding upon any persons or members of my family, including minors who may accompany me. I declare I am over the age of eighteen (18) and fully able to enter into a legally binding Agreement.

I HAVE CAREFULLY READ THIS AGREEMENT AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS IS A BINDING LEGAL CONTRACT BETWEEN MYSELF AND ENTROPY RACING AND/OR ITS AGENTS, AND I SIGN THIS OF MY OWN FREE WILL.
